RANK: Lecturer

SALARY: \$5,259 to \$5,950 per 5-unit course, commensurate with qualifications and experience. The campus operates on a schedule of three 11-week quarters per academic year. A full time appointment is based upon an eight course equivalency.

MINIMUM QUALIFICATIONS: M.F.A. in a relevant field of study or equivalent professional experience. Demonstrated potential for excellence in innovative research and/or creative work and for university teaching. University teaching experience preferred.
