**RANK:** Lecturer

**SALARY:** Minimum \$6000 per 5-unit course, commensurate with qualifications and experience. The campus operates on a schedule of three 11-week quarters per academic year. A full time appointment is based upon an eight course equivalency.

**MINIMUM QUALIFICATIONS:** M.F.A. in relevant field of study or equivalent professional experience. Demonstrated potential for excellence in creative work and for university teaching. University teaching experience preferred.
